Dr. Elayne Pope researches the process of how the human body burns in a variety of forensic fire environments as for training law enforcement, death investigators, and fire investigators. Dr. Pope works as a forensic anthropologist for the Tidewater District Office of the Chief Medical Examiner in Norfolk, Virginia. She has lectured extensively for various state chapters of the International Association of Arson Investigators and works closely with the fire investigative community to replicate forensic casework.

Captain Phillip Calvert is recently retired as an Assistant Director for the Alabama Alcoholic Beverage Control Board's Law Enforcement Division. He also served as the agency's Accounting Director where he was responsible for revenues totaling almost \$500 million annually. Phillip has over twenty-six years of law enforcement experience with the Hanceville Police Department, Cullman County Sheriff's Department, and Alabama ABC Enforcement. He is a graduate of the FBI National Academy's 237th Session, holds BS and MS degrees from Faulkner University, and continues to work on graduate level Criminal Justice courses toward a doctorate. This training has been presented successfully to more than 500 law enforcement officers and investigators.

Statement Analysis I

The specific words used by a suspect or victim reveal a lot about what they want you to believe. Statement Analysis examines the words used by a suspect or victim and uses them to help plan specific interview strategies. Officers using this analysis are much more prepared to testify in court about deception in a person's statement and will be prepared to explain to a judge or jury why they have perceived that deception, instead of just having a gut feeling.

This course will take the participants through the process of gathering a useful statement, detailed presentation of materials, discussion of cases, practical exercises, and tools that can be used after leaving the classroom. It is amazing how much people will reveal when you look at their words, word structure, and how they relate to a crime scene.

Statement analysis has been useful in solving crimes, verification of false reports, gaining confessions, clearing innocent suspects and may be useful in all types of investigations. This is a tool that can be used by patrol officers and investigators to document and analyze statements that may help them solve crimes more quickly.

Statement Analysis II

Statement Analysis II is a continuation of the skills presented in Statement Analysis I. Those wishing to register for this course should have completed Statement Analysis I prior to attending this seminar. Statement Analysis II will include a review of previously presented material along with new skills used to examine the words used by a suspect or victim and helps to plan specific interview strategies. Officers using this analysis are better prepared to testify in court about deception in a person's statement and will be prepared to explain to a judge or jury why they have perceived that deception, instead of just having a gut feeling.

This course will take the participants through detailed presentation of new material, discussion of cases, in-depth practical exercises, and practical use of techniques that can be used after leaving the classroom. It is amazing how much people will reveal when you look at their words, word structure, and how they relate to a crime scene.
